RAR IS OPERATED THROUGH A DIVERSE NATIONAL NETWORK OF AFFILIATES (E.G., SCHOOL SYSTEMS, LIBRARIES, OR COMMUNITY AGENCIES) AT MORE THAN 2,900 LOCATIONS NATIONALLY, SERVING FAMILIES WITH CHILDREN BETWEEN THE AGES OF 0 TO 8 YEARS OLD.
